# Consulting

# **Introductory Consultation**


For laboratories that wish to improve patient safety and quality of care, we identify their strengths and challenges in relation to meeting the accreditation standards, and introduce them to the essential quality requirements to benchmark with international accrediting bodies such as CAP, ISO or other accreditation preparation processes. This consultation offers highly customized learning, high-level assessment and practical advice. A consultant from MedLabs joins the manager of the laboratory's Quality Department or other senior staff to evaluate the laboratory's existing quality practices, provide mentoring and education and conduct meetings to help create a plan for moving forward to implement a complete quality management system.



#### Phase II:

# **Laboratory Assessment**

This baseline assessment provides an in-depth review of the laboratory's ability to meet the required quality accreditation standards. Results are summarized in a comprehensive report from which immediate improvement activities can begin.



#### Phase III:

## **Ongoing Assistance & Staff Training**

We help laboratories maintain momentum by training staff on the implementation of accreditation standards. Standard Operating Procedures are prepared covering technical, quality and safety aspects. Assistance can be delivered during this phase through off-site support that may include e-mail and Skype communications, review of policies and procedures, laboratory or quality improvement data, periodic conference calls as well as actual on-site visits.

# Simulated or Mock Inspection

For a Laboratory that has implemented significant levels of accreditation preparation, a simulated inspection that allows the laboratory team to practice the actual accreditation inspection process offers a comprehensive assessment of accreditation readiness. A meeting with all staff is conducted to make sure that they are technically & psychologically prepared for the actual inspection.

# ISO 15189 Laboratory Accreditation

MedLabs was the first laboratory in Jordan and the region to be awarded the ISO 15189 Laboratory Accreditation (specific requirements to ensure Quality, Competence and Reliable Results) by the Accreditation Unit / Jordan Institution for Standards and Metrology in cooperation with the European Union. MedLabs is currently accrediting its regional laboratories as well.
